Report of Foreign Bank and Financial Accounts (FBAR)

Every year, under the law known as the Bank Secrecy Act, you must report certain foreign financial accounts, such as bank accounts, brokerage accounts and mutual funds, to the Treasury Department. You must also keep certain records of those accounts. You report the accounts by filing a Report of Foreign Bank and Financial Accounts (FBAR) on FinCEN Form 114.

The FBAR is an annual report, due April 15 following the calendar year reported. You're

allowed an automatic extension to October 15 if you fail to meet the FBAR annual due date of April 15. You don't need to request an extension to file the FBAR.

Who must File? A United States person, including a citizen, resident, corporation, partnership, limited liability company, trust and estate, must file an FBAR to report:

- 1. a financial interest in or signature or other authority over at least one financial account located outside the United States, if
- 2. the aggregate value of those foreign financial accounts exceeded \$10,000 at any time during the reporting calendar year.

Generally, an account at a financial institution located outside the United States is a foreign financial account. Whether the account produced taxable income has no effect on whether the account is a "foreign financial account" for FBAR purposes. This means that many of our members residing in Thailand that have the bank funds required by their respective visa fall into this category and must file the FBAR report. The web address below will take you to the efiling website

https://bsaefiling.fincen.treas.gov/NoRegFBARFiler.html . Just follow the instructions.

You must file the FBAR electronically through the Financial Crimes Enforcement Network's <u>BSA E-Filing System</u>. You don't file the FBAR with your federal tax return. The FBAR is required by the Treasury Department and is separate from any IRS filing obligations.



Safety Message: Ladder safety Month.

The OSHA Training Institute Education Center (OTIEC) provide these

Ladder Safety DOs and DON'Ts

To prevent from being injured due to falls from various types of ladders, including extension ladders and stepladders, you are encouraged to adopt the following practices: DO:

Safe Extension Ladder Use—

- Maintain a 3-point contact (two hands and a foot, or two feet and a hand) when climbing/descending a ladder.
- Face the ladder when climbing or descending.
- Keep the body inside the side rails.
- Use extra care when getting on or off the ladder at the top or bottom.
- Avoid tipping the ladder over sideways or causing the ladder base to slide out.
- Carry tools in a tool belt or raise tools up using a hand line. Never carry tools in your hands while climbing up/down a ladder.
- Extend the top of the ladder three feet above the landing.
- Keep ladders free of any slippery materials.

Safe Extension Ladder Use—DON'T:

- Place a ladder on boxes, barrels, or unstable bases.
- Use a ladder on soft ground or unstable footing.
- Exceed the ladder's maximum load rating.
- Tie two ladders together to make them longer.
- Ignore nearby overhead power lines.
- Move or shift a ladder with a person or equipment on the ladder.
- Lean out beyond the ladder's side rails.
- Use an extension ladder horizontally like a platform.

Safe Stepladder Use—DO:



Read and follow all the manufacturer's instructions and labels on the stepladder.

- Look for overhead power lines before handling or climbing a ladder.
- Maintain a 3-point contact (two hands and a foot, or two feet and a hand) when climbing/descending a ladder.
- Stay near the middle of the ladder and face the ladder while climbing up/down.
- Use a barricade to keep traffic away from the ladder.
- Keep ladders free of any slippery materials.
- Only put ladders on a stable and level surface that is not slippery.

Safe Stepladder Use—DON'T:

- Use stepladders for a purpose other than that for which they were designed.
- Use a stepladder with spreaders unlocked.
- Use the top step or cap as a step.
- Place a ladder on boxes, barrels or other unstable bases.
- Move or shift a ladder with a person or equipment on the ladder.
- Use cross bracing on the rear of stepladders for climbing.
- Paint a ladder with opaque coatings.
- Use a damaged ladder.
- Leave tools/materials/equipment on stepladder.
- Use a stepladder horizontally like a platform.
- Use a metal stepladder near power lines or electrical equipment.

Most falls (79%) resulted from excessive reaching or incorrect ladder placement.

How to make ladders safer?

The options are as follows:

- 1. Tie the ladder to a suitable point, making sure both stiles are tied.
- 2. Where this is not practical, secure the ladder with an effective ladder stability device.
- 3. If this is not possible, securely wedge the ladder (eg wedge the stiles against a wall)

One final note try to use this in unison of fall protection According to the CDC, each year, millions of older people—those 65 and older—fall. In fact, more than one out of four older people falls each year, but less than half tell their doctor. Falling once doubles your chances of falling again.

Falls are serious and costly

- One out of 10 falls results in an injury that causes the older adult to restrict their activities for a day or more or to seek attention from the healthcare system.
- Each year, there are about 3 million emergency department visits due to older people falls.
- Each year, there are about 1 million fall-related hospitalizations among older adults.2
- In 2019, 83% percent of hip fracture deaths and 88% of emergency department visits and hospitalizations for hip fractures were caused by falls.3
- Each year, nearly 319,000 older people are hospitalized for hip fractures.
- Falls are the most common cause of traumatic brain injuries (TBI).

Could you imagine someone you know being born with this? Can you imagine their future, their quality of life? It's estimated that 5 out of 1,000 children in Thailand are born with a facial deformity. You may think 5 out of 1,000 isn't much but it is if it is your kid.

On March 11,2025 members of our post will go to Khon Kaen University to meet with the Tawanchai Foundation to present a check for \$1,000. This will be our fourth year supporting the foundation. VFW Post 10217 Korat, Thailand will again be joining us for the third time in also donating \$1,000. We are both committed to supporting Tawanchai every year.

The Tawanchai Foundation provides corrective surgery, counseling, support and more, **FREE OF CHARGE** to any child born with a facial/cranial deformity. They do fantastic work! The photo above shows the result. I have seen photo's much worse than this and the outcome is unbelievable. One hundred percent of our donation goes to the child and family to finance their travel and stay while the child is undergoing treatment. The foundation does not stop there. They follow and provide counseling and medical support to the child into adulthood.

Our Post is committed to the fourth pillar of the American Legion which is all about children. There are many different programs for children and they are all good. This commitment we chose gives a child a shot at a normal life. It puts them on equal footing for whatever life holds for them. I cannot think of a better way to help them.

We are now looking at next year's donation. Currently we have 77 members. To reach our goal of \$1,000 would take \$12 from each of you. A small donation to give a child a shot at a normal life. From what I have been reading, that is less than a cheeseburger in the US.
