Operation Comfort Warriors

Established in 2007, and now a specific program of the American Legion Charities, Inc. 501(c)(3), OCW provides comfort items to those who are wounded, injured or ill in military and federal veterans' health-care facilities. Funds are used to purchase items not normally provided by the federal government, such as art and sports therapy equipment, recreational opportunities and entertainment for the wounded servicemembers and their families.

National Emergency Fund

The fund directs immediate cash grants to Legionnaires whose homes were affected by natural disasters such as wildfires, tornadoes, hurricanes and floods. Legion posts are also eligible for emergency assistance.

TRUST FUNDS AND CHARITABLE PROGRAMS

American Legion Veterans and Children Foundation

The American Legion Veterans and Children Foundation provides financial support to the children and youth, and veterans rehabilitation programs of The American Legion. Income is restricted to funding programs such as Temporary Financial Assistance, veteran service officer training schools and VA Board of Appeals staff training.

American Legion Charities, Inc. 501(c)(3)

This is a charitable corporation established by American Legion National Headquarters to receive bequests from individuals, corporations or foundations to fund veterans programs for unrestricted or restricted gifts to assist veterans or their families. Donations may include specific bequests to fund programs such as American Legion Boys Nation and Boys State, American Legion Baseball, The American Legion Oratorical

Program and others that support children and youth activities or the general charitable programs of The American Legion.

American Legion Child Welfare Foundation, Inc.

Created by The American Legion in 1954, as a separate 501(c)(3), the Child Welfare Foundation awards grants to nonprofit organizations that contribute to the physical, mental, emotional and spiritual needs of children and youth; to improve the lives of children and youth through funding projects or in other ways, including youth activities and programs sponsored by The American Legion.
